I. DEFINITIONS

The following definitions apply throughout these Terms and Conditions:

- “Applicant” means an individual or entity seeking admission to become a Member of CCI France Myanmar
- “CCI France Myanmar” means the French Myanmar Chamber of Commerce and Industry registered in Myanmar
- “Member” means an individual or entity having successfully registered as a Member of CCI France Myanmar

II. HOW TO APPLY FOR MEMBERSHIP?

V. CONDITIONS

Payment of full membership fees by the Applicant gives rights to a whole year of membership, **starting from the date of payment at any time during the year for new Members, and on the anniversary date of first payment of Membership for renewed Members.**

5.1 –Membership renewal

Renewal membership fees have to be paid in full one month before the end of the Membership. In case of non-payment of membership fees at the end of one-year term of the Membership, all membership rights and benefits will be forfeited and lost by the Applicant. In that case, the Applicant will not be considered to be a Member of CCI France Myanmar anymore until payment is received.

In case of delayed/late payment of the renewal of Membership, the validity of the renewed Membership will be one year starting on the anniversary of the date of the first payment of Membership.

5.2 – New membership

Any new applicant must pay the full Membership fees for one year to become a member of CCI France Myanmar. The Membership term is one full year starting on the date of payment of the Membership fees.

Applicants have to meet the conditions of the type of membership for which they apply. CCI France Myanmar reserves the right to terminate a membership, including without limitation, if the Member has provided false information, does not meet the conditions attached to its selected type of membership, or does not abide by the provisions of CCI France Myanmar’s Memorandum and Articles of Association..

In case of termination of the membership by CCI France Myanmar, the terminated Member will only be entitled to the refund of its membership fees on a pro-rata basis calculated according to the remaining number of days until the end of the concerned one-year term of Membership.
