Company representatives are highly encouraged to attend the Young Entrepreneurs Awards Ceremony. CCI France Myanmar will be announcing the nominees prior to the event, the winner will only be announced during the Awards night proper. If a winner is not present the Young Entrepreneurs Awards Ceremony, they will forfeit their prizes and awards (please check the Terms & Conditions).

In addition to the present form, the company entering the Myanmar Young Entrepreneurs Awards 2018 contest must provide the following documents:

- Your logo in high-resolution, at least 300 dpi (.pdf, .ai, .png, .eps or .jpg)
- A high-resolution picture of your CEO/Chairman/Founder/President
- A high-resolution picture of your activity/product/company in high-resolution, at least 300 dpi, format 43 x 24 cm
- Your slogan/motto or a sentence illustrating your identity/concept/activity
- Forms 6 and 26
- PPT with presentation of the company and photographs (4 pages maximum)
- Any other document (5 pages maximum), photo or video that you think might interest the jury
